IV. New Business

- a. SFRB is pushing the UCA shuttle vote back for next week
- b. If we are going to go for the grant funding for transit shelters, we need to decide tonight how much we are contributing.
- c. Gillette Drive vs. Corridor Infrastructure Discussion
 - i. Engineering: corridor infrastructure should be rated higher than Gillette, but Gillette is great.
 - ii. Engineering: Seconded. The streetlight and beacon are great but it also needs a speed table to be even better.
 - iii. ASCSU Sofia: Gillette is really important and serves an important community.

- iv. ASCSU Haydyn: Gillette should be #4. Safety is more important than other things.
 - v. ASCSU Evan: Gillette should be #4.
 - vi. Ag Science: Gillette and Corridor are both important, but Gillette is better because it addresses an issue directly.
 - vii. CVMBS: I like Gillette. Not a fan of more speed tables on Pitkin and Hughes anyway
 - viii. Chair: Like Gillette because it's well planned, and it will be immediate and permanent.
 - ix. Vice chair: it's important to follow the ranking scheme we set. Overall, the ranking is good where it is now.
 - x. Finance: Gillette is great because it's immediate. Corridor will serve more people but take longer. It has a higher cost benefit ratio and for that I like it more. The corridor also has matched grant funding which is huge plus.
 - xi. Grad School: Corridor will have more impact on more students
 - xii. Grad school: it's hard to juggle immediate benefit and long-term benefits. In this case, I think we should focus long-term on investment.
- d. Open discussion after motion 1
- i. Engineering: how much would be cut from transit shelters if we fund Gillette and Corridor?
 - 1. We can fund both and still fund Transit
 - ii. Motion 1 passes—Gillette is #4
- e. Mobility Charging
- i. Motion 2 to strike funding
 - ii. We will send out a notification telling them why we denied their proposal.
- f. Corridor infrastructure vs pavement markings discussion
- i. Natural Science: Corridor is better
 - ii. Grad school: safety is more important than clarification via markings
 - iii. Warner: Seconded

- iv. Finance: Seconded
- v. Vice chair: We should try to fund pavement markings because we identified it as a problem at the beginning of the year and they made the whole proposal because of that.
- vi. Chair: I favor the pavement markings if there's money because it benefits students now rather than later.
- vii. CVMBS: pavement markings don't do a good enough job clarifying things, so I ranked corridor improvement over pavement markings
- viii. Ag Science: Seconded
- ix. ASCSU Evan: Corridor could save lives and decrease risk, while Pavement Markings probably won't as much.
- x. ASCSU Haydyn: If we fund Pavement over Corridor, we won't have to fiddle with transit funding and partially fund it.
- xi. Engineering: Corridor is great as #5
- xii. Open discussion after motion 3
 - 1. Grad school: we should consider Pavement as #5 because we as a group prefer it over Corridor. Less volatility in the scores. We asked for Pavement Markings in the fall.
 - a. ASCSU Evan: yes we did ask for it, but we also didn't know what else was going to be proposed
 - b. Warner: if CSU is going for vision zero goal, then Corridor should be #5 because it aligns with vision zero.
 - c. Finance: I agree with both points. Yes we asked for Pavement Markings. Yes Corridor Infrastructure aligns better with vision zero. Pavement markings help prevent bike-ped collision while the corridor improvements prevent car-ped crashes which are more fatal.
 - d. Warner: if we don't fund the markings, that's not great for our credibility
 - g. Funding left available after last meeting

- i. Brain: We can fully fund everything we have left on the table (Transit Shelters, Gilette, Corridor, and Pavement)
- ii. Open discussion on transit shelters
 1. Natural Science: out of all years we should fund it now because of the possibility for a grant match.
 2. Warner: Agree, it needs funding now. We should strike out the Libbie Coy Way shelter that would only see 2,000 riders a year
 - a. Finance: all the shelters are a part of the CSU master plan. They will keep coming to us every year until all of them are built. If we get the grant funding, we can knock all of those at once. If we throw one out, it'll just need funding later
 - b. Warner: retract statement
 3. Engineering: if SFRB comes back and says we need to contribute funding toward the shuttle, can we rescind motions to move around funding to get enough funding for that?
 - a. Jamie & Chair: the transit shelters are more pressing because of the grant deadline, however changes could be made. Changing motions & allowing SFRB to tell us how to spend money is setting a bad precedent. SFRB's job is not to tell us how to distribute funding, they just make sure we are responsible in how we do that.
 4. Chair: If we fully fund Corridor, we should take the money from Transit because it has the most flexibility.
- iii. Motion 4 to use all the funding tonight
 1. Grad school: I agree with the motion. Our discretionary funding doesn't work well for funding stable salaries. I don't want anyone to have to make that decision to fire someone because we ran out of funding.
 2. Warner: Didn't we have a back up plan for the shuttle should the fee increase fail?

- a. Vice chair: our plan B was to cut one shuttle. They haven't asked about anything to that effect. They are concerned with if we can use discretionary funding now to reduce the fee increase burden for the next five years. That concern side cuts our plan B.
 - iv. What does the budget/numbers look like
 1. Brian: We can fund all the projects in full and still have some money to fund 1 year of the UCA shuttle
 - v. Motion 5 to fund everything else
 1. ASCSU Haydyn: If we motion to fund everything now but something changes in the future, how will funding be allocated?
 - a. Pavement markings would get cut first because of how we ranked it. Things that are top ranked should get fully funded first before everything below it.
 2. Finance: With Brian's info, we can fund everything. However, if we fund one year of the shuttle, it would be entirely dependent on discretionary funding
 - a. Grad school: If we set that precedent, SFRB could continually ask us to fund things on our own, which leaves us very little for new projects in the future.
 3. Warner: by funding it for one year, we do get a sample of what it looks like and we can take that to SFRB as a case study.
 4. Natural Science: Can we work with SFRB to fund 3 years of the shuttle with our leftover funding + a smaller fee increase.
 5. Vote on motion 5. Motion passes
